
The recently concluded 9th Governing Council Meeting of Niti Aayog, once again reiterated the commitment to the ambitious Viksit Bharat at 2047 program, whereby India would strive to be a \$30-trillion economy (up from the current \$3.36 trillion) with a per capita income of \$18,000 per annum (up from the current \$2,392 annum) by 2047. 



President, Ghaziabad Chapter, Mr. Vipul Giri and GC Member of CREDAI Western U.P. Shri Naveen Goel, among others.


The seminar focused on key provisions of the RERA Act, recent office orders, and related aspects. Discussions aimed at ensuring uniformity in promoter activities and addressing issues such as Occupation Certificate (OC) / Completion Certificate (CC) requirements, maintaining accounts, and quidelines for ownership and advertisements. Chairman Shri Sanjay Bhoosreddy emphasized the importance of regular seminars for better regulation and stakeholder protection. The seminar included detailed discussions on project registration to account closure, compliance. and ways to avoid penalties.

On July 11, 2024, CREDAI Haryana Chapter held an urgent meeting to address a notice issued by the Department of Town and Country Planning Haryana, which directed 38 developers to address maintenance issues in Group Housing Societies.

While acknowledging the intent to ensure public good, the notice was seen as unfairly burdensome since many societies are now managed by their Resident Welfare Associations (RWAs), and issues like sewage and road maintenance fall under municipal or government jurisdiction. The meeting called for a clear mechanism to assign maintenance responsibilities fairly among developers, RWAs, government agencies, subcontractors, and suppliers to achieve better maintenance outcomes.

The interactive session provided valuable insights and opportunities for collaboration. This also highlighted CREDAI NCR's commitment to urban development in the National Capital Region.






