This edition of NATCON has further strengthened CREDAI's vision for building a new India, with insightful discussions on sustainable development, investment, finance, project management, productivity, and more.

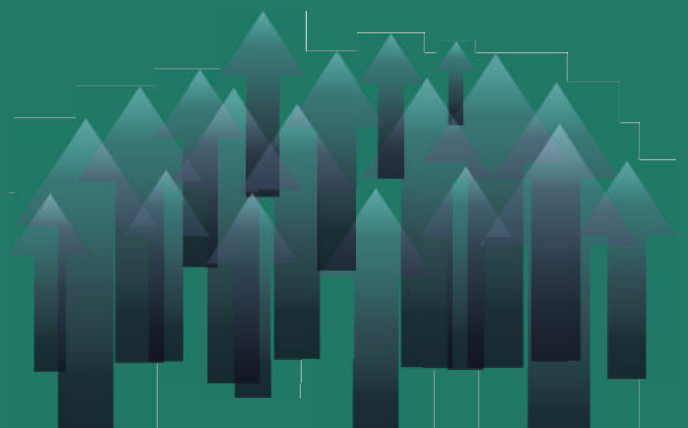

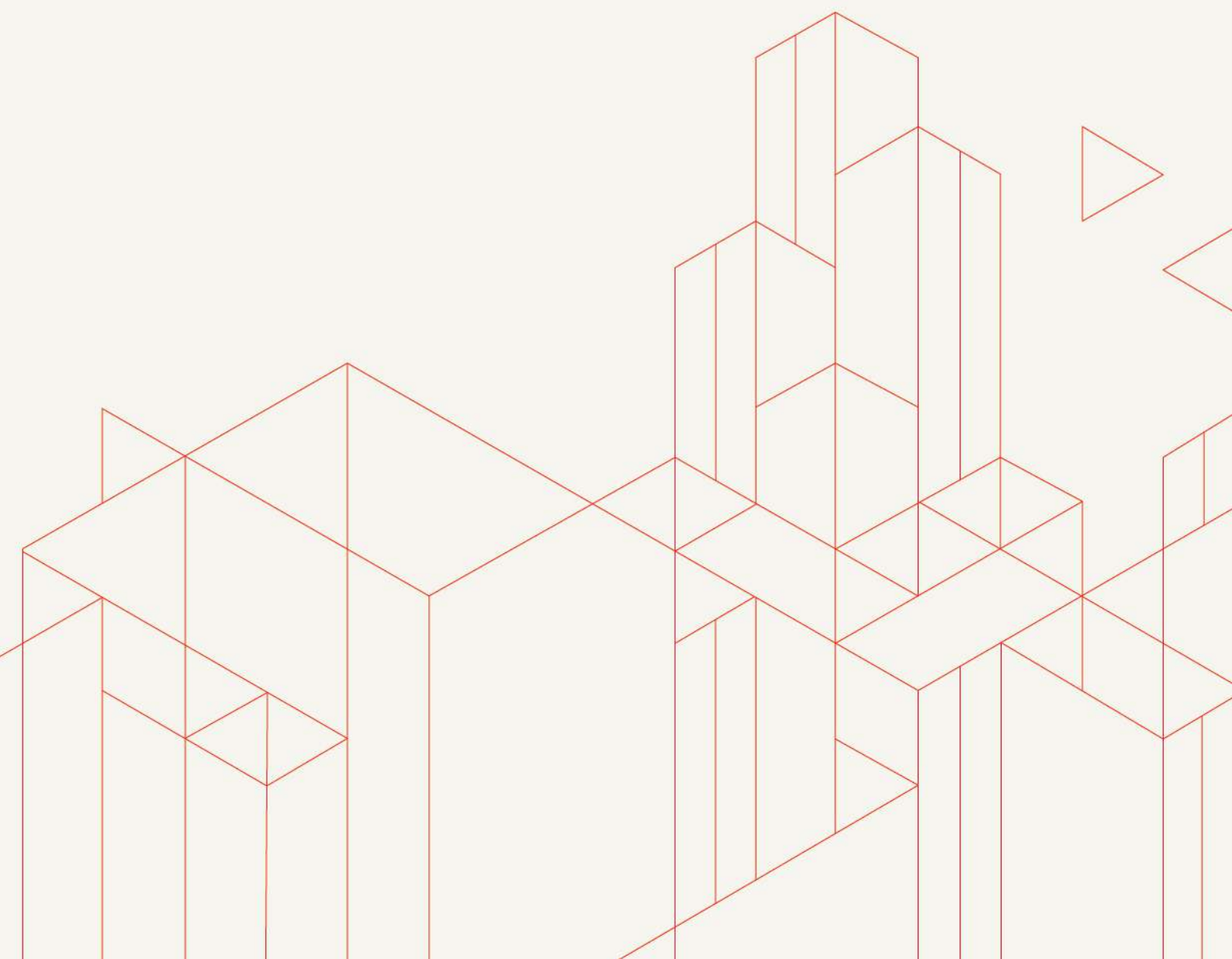

The meeting also facilitated networking among members, reinforcing the chapter's commitment to supporting the growth of the Vizianagaram real estate sector.

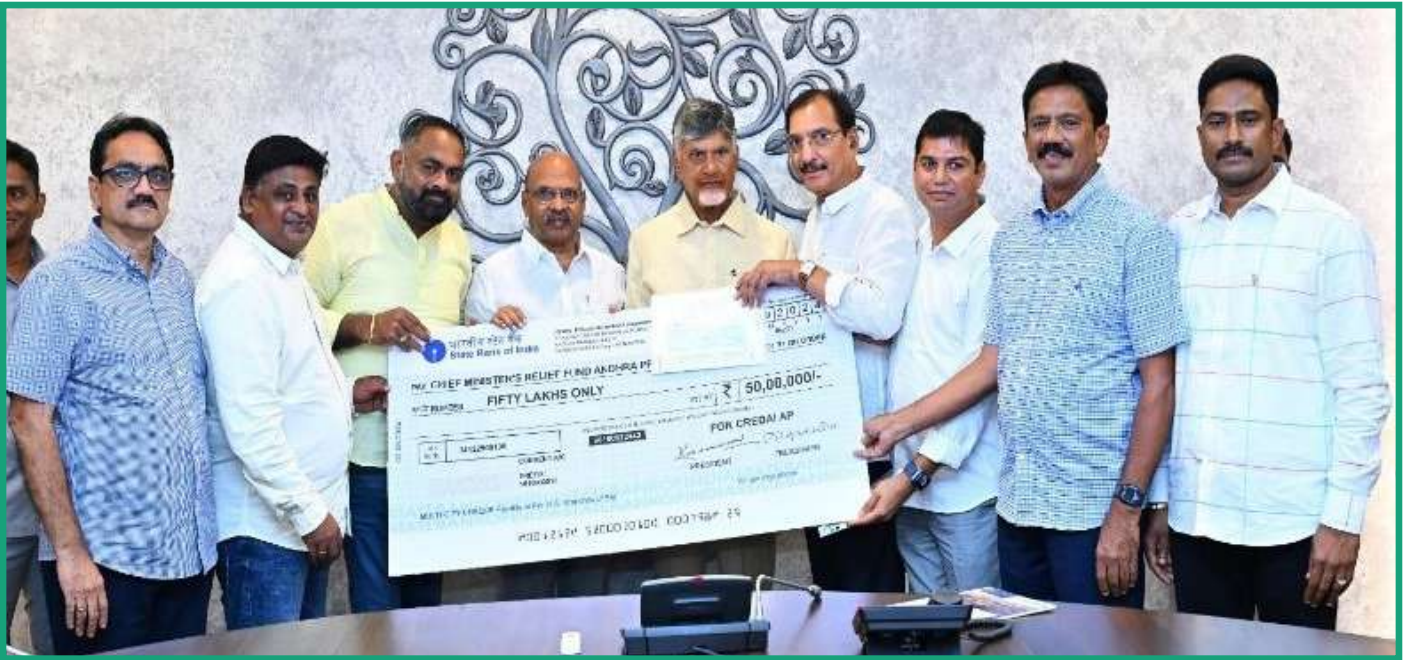


**CREDAI Vijayawada organized General Body Meeting**

### CREDAI Andhra Pradesh hosted SOUTHCON 2024

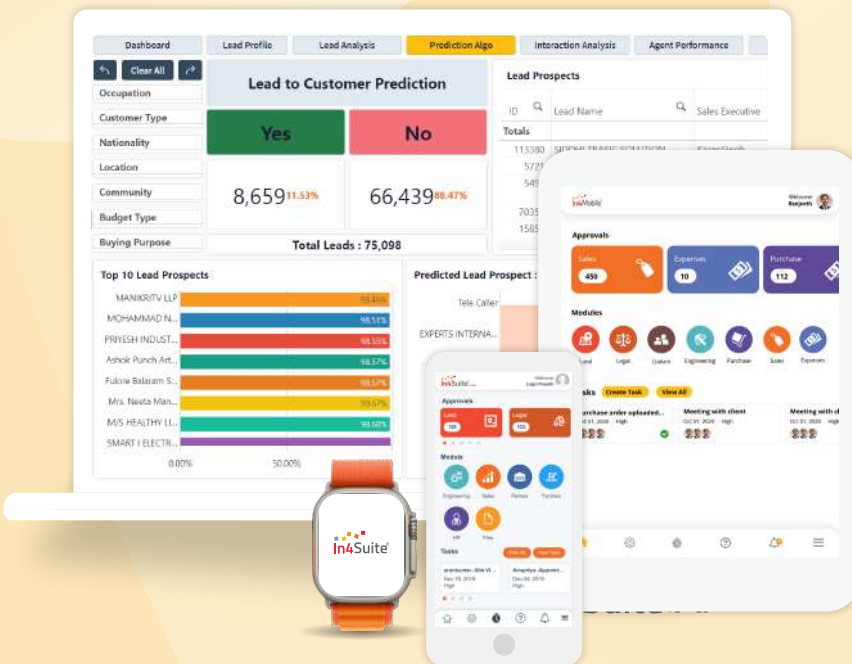

### **Discussion on Innovation Hub Partnership with SI-8 Foundation**

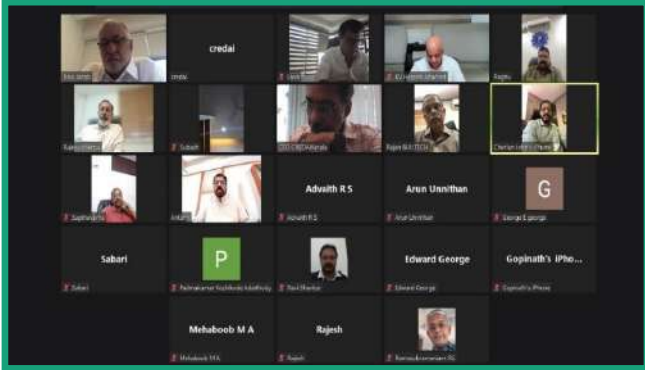

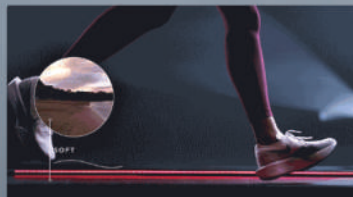

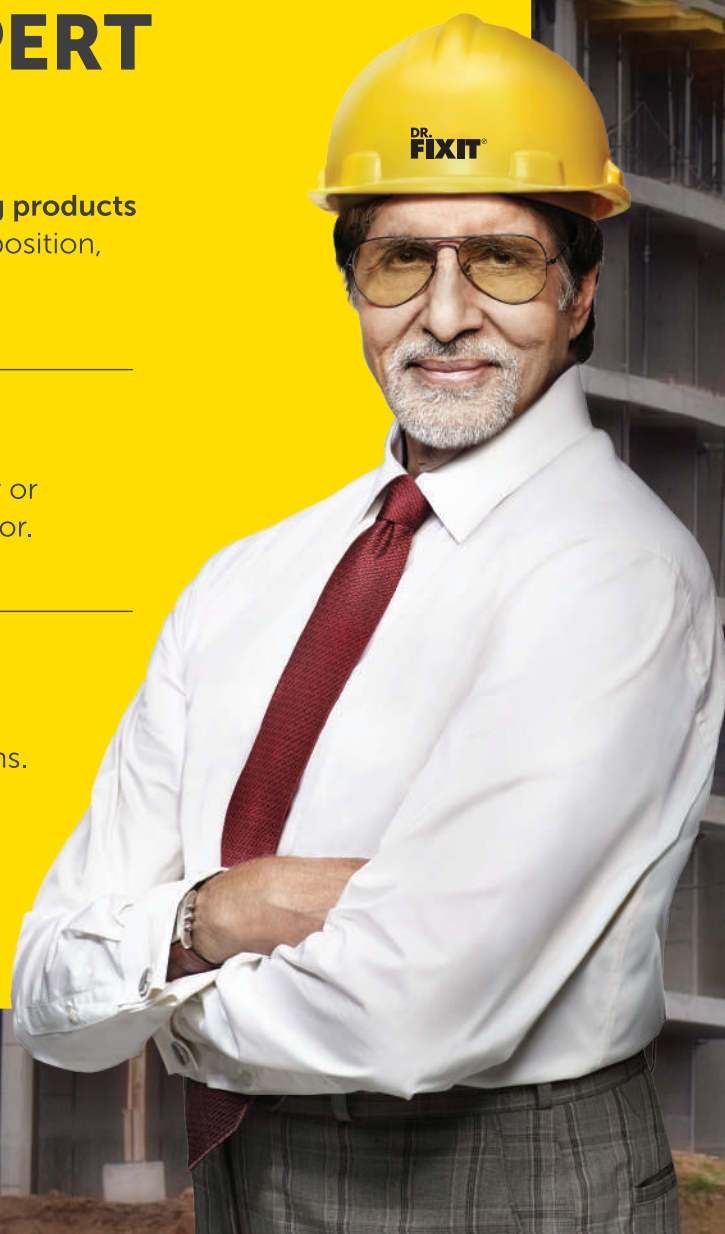

## ENERGY EFFICIENT EXTERNAL WALL SYSTEMS, THE INCREASING TREND PART 1

The ever-evolving facade landscape presents a complex challenge for construction professionals. Balancing sustainability benchmarks such as energy efficiency and durability with aesthetic appeal and affordability requires meticulous design of facade configurations, material selection, and installation expertise.

Incorporating unique shapes, paints and textures contribute to the facade's character and appearance. However, beyond the aesthetic appeal, the quality of a façade largely hinges on its functionality and durability. With depleting energy resources, increasing costs of air-conditioning, and stringent energy conservation directives from the government, thermal insulation for building envelope is a must-have feature. Hence, for both ecological and economic reasons, external wall insulation systems are becoming an increasing need today. External Insulation and Finish Systems (EIFS) are now a critical solution, aligning ecological and economic imperatives.

### IMPORTANCE OF BUILDING ENVELOPE INSULATION

The “building envelope” refers to the external walls, windows, roof, and floor of a building. A building's envelope, especially roofs & walls, contribute to as much as 28% & 45% of the total heat gain in buildings. Good thermal insulation for the envelope is crucial to prevent heat from seeping in through the exterior of the building. By externally insulating the building envelope, we can prevent the entry of heat into the structure which reduces the load on air conditioning systems. This minimizes energy consumption which in turn reduces capital & operating costs and improves the thermal comfort for end user.



### Typical heat gain/energy losses from a building without proper insulation

With several state governments in India mandating the implementation of Energy Conservation Building Code (for commercial buildings) and Eco-Niwas (for residential buildings), insulating the envelope has now become an increasing need. The thermal insulation systems can be designed with different thickness to achieve the prescribed roof and wall assembly U-Value requirements as per ECBC (for commercial buildings) and RETV values as per Eco-Niwas Samhita for residential buildings.



### GNIDA Interactive Meeting with Real Estate Developers

On 6th September, an interactive meeting organized by the Greater Noida Industrial Development Authority (GNIDA) took place under the chairmanship of Officer on Special Duty (OSD) Shri Somya Shrivastava at the GNIDA office in Knowledge Park IV. The meeting saw participation from 51 real estate developers and aimed to foster dialogue on compliance, dues, and pending issues in the sector.

Shri Shrivastava praised the efforts of CREDAI NCR's Western U.P. Chapter in collaborating with the Government of U.P., noting the recovery of ₹ 580 crores from developers based on the Amitabh Kant report. He urged developers with unpaid dues to clear their outstanding payments within 15 days, warning of strict actions for non-compliance.

The issue of compensation for farmers was also discussed, with Shri Shrivastava advising CREDAI NCR representatives to meet with the Chief Secretary of Uttar Pradesh to seek solutions, as the related case is pending in the High Court. The meeting concluded with a strengthened commitment to collaboration among GNIDA, CREDAI, and the developers to address ongoing challenges and promote sustainable growth in the sector.

Additionally, the validity of sanctioned plans in Ghaziabad was extended from 5 years to 7.5 years, offering developers more flexibility.

Routine agenda items, including the adoption of the balance sheet and appointment of auditors, were addressed. The meeting concluded with plans to meet Chief Secretary Shri Manoj Singh to discuss time extensions, farmer compensation, and lease rent. 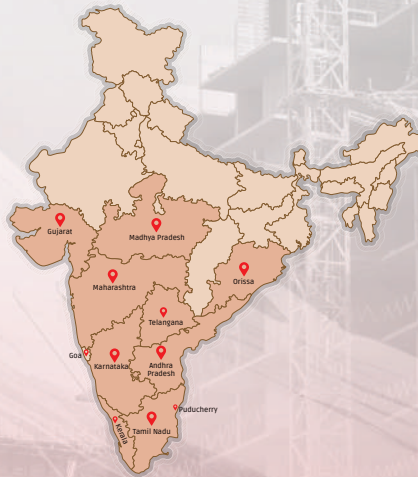
