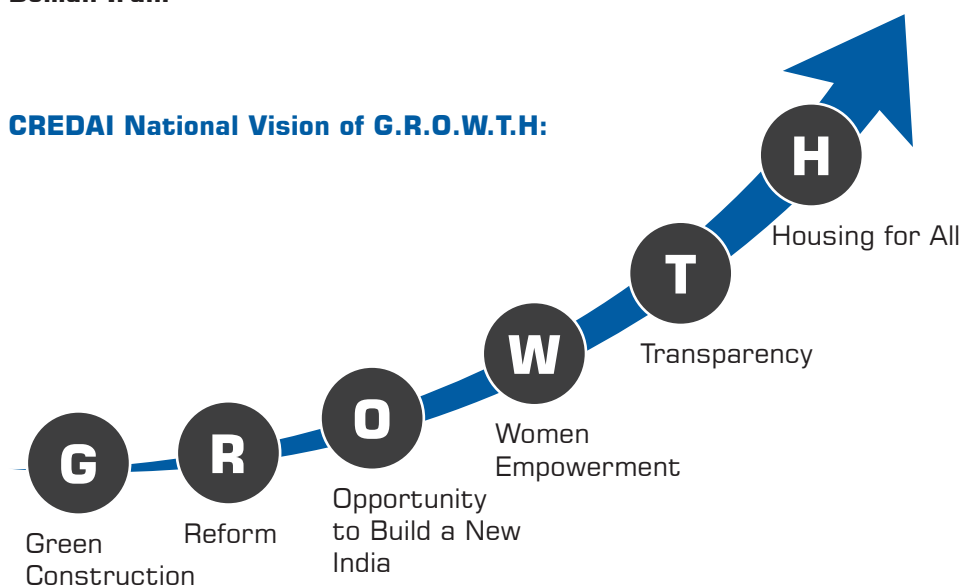

Meeting with the Hon'ble Minister for MA&UD

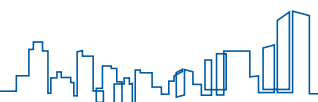

On March 4, 2025, the CREDAI NCR Haryana Chapter met the Chairman of HARERA to address key regulatory challenges and improve transparency in the real estate sector. A delegation of prominent developers discussed critical issues, including the 5% bank guarantee requirement, recognition of the Occupancy Certificate as a Completion Certificate, high RERA registration fees, and delays in fund release post-project completion.

The delegation also sought an extension for quarterly compliance report submissions, consistency in judicial orders, a three-year complaint limitation period, and recognition of force majeure delays. While HARERA assured a review of several concerns, it declined to consider force majeure exemptions.

The meeting reinforced the need for continuous dialogue between developers and regulators to foster a business-friendly environment while ensuring compliance and sectoral growth.

The event proved to be highly informative and impactful, equipping participants with crucial knowledge for safeguarding women's health.

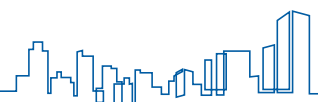


Gratitude Ceremony organized by CREDAI Pandharpur
